SDA health message

The world through their evolutionary stand point hopes to improve on nature rather than working by an understanding of nature's laws of which they are ignorant. Tell me what does medical science really understand of the basic principles of health as we compare that to church's fundamental health message given to us in 1863?

The Virus

Viruses are the focus of the world because of covid 19, which has become the opportunity to develop new generation **genetic engineering drugs.** All viruses are an outer shell of protein which encapsulates the virus' DNA (or RNA) – the genetic code with the instructions for making new copies of the virus. When we say virus, we think of 'germs,' something that must be eradicated and that thinking has been fundamental to the drug industry and passed to the general public. Such an understand does not picture the cycle of life in which we live of which the Bible speaks of. We should understand as with microbes, viruses work for or against us depending on the terrain in which they find themselves, that is for life or dust to dust, ashes to ashes. Viruses are not alive but communicate a set of instructions to the cell. The virus is alive only when it enters the cell with its message or instructions. What is wrapped up in the genetic dispatch turns out to be bad or good news depending on the terrain the virus finds itself. The virus is specific for species as for organs in

the body. If it is an external threat it finds no home in a fortified system but in a compromised system is easily finds its home and delivers its payload. What are viruses? - tiny protein bubbles which regulate life such as our immune system, growth of embryos and so on.

The human endogenous retrovirus with its genetic sequence turns on during the development stage and produces proteins. HERV-K is thought to protect the embryo from infection and help fetal development. By the time a human embryo has grown into a many cell blastocyst HERV-K is concentrated in the cells that will become the baby.' National Geographic Mysteries of a virus 02.2021 p50. Viruses were thought of as nonliving entities that infected a cell, to multiply itself and cause disease. Now we know or should understand basics, that they not only cause disease by their genetic payload but they are part of life and in fact to live, to give birth is impossible without viruses.

Every day we each breathe in over 100,000,000 viruses. We are constantly breathing and drinking viruses and they are found high up into the stratosphere as on the earth.

Mammals can carry up to 320,000 different species of viruses. To say that a virus is a parasite at this point I think is a poor analogy. Viruses make up the cycle of life. Not only is there the vertical replicating of the cell in division or reproduction but the horizontal environmental factors that are taken into the genetic makeup of the person and can be passed down genetically to offspring.

The concept of enhancing evolutionary development rather than working with nature or by its natural laws is what is behind viral labs across the world, enhancing viral virulence with gain-of-function research which I believe is a criminal act. The **Biological Weapons** Convention (BWC) signed in 1972 has meant all such further biological research carried out worldwide was said to be done in the interest of research and national health.

When you are infected with a virus a part of that virus will be *encoded in your DNA for the rest of your life.* So, a disease weakens rather than fortifies the system. Retroviruses are expressed in autoimmune disorders. It is well known that viruses are necessary for placenta development in fact it has been stated from viruses come everything; but this thought is from an evolutionary stand point. Viruses contain code that change the body's DNA and 'It has been suggested that viruses are not only necessary for the existence of placental mammals, but also for the existence of life in general.' A part of the mystery that surrounds the virus is such because science has not discovered the natural laws by which the human machinery operates. When we consider the cycle of life as given to us in Genesis 2 & 3 and understand the body operates as a clean operating system (Levitical law) we are on our way to understanding true healing.

Most people though 'educated' do not know the fundamentals of health and healing. Medical superstition has allowed people to believe that good health is mass inoculation and medicated- such is impossible and naïve. We to a large degree shall revisit medieval times because of this basic lack of understanding, allowing control over our quality of health and personal data. This should never have happened.

The body machinery works off laws. You say what laws? Such laws are evident in physics, flight, electricity etc. The laws spoken of here such as rest patterns, removing free oils, inhaling fresh air in ventilated rooms etc. The result is to be ideally an internal clean, nutrient-rich system for self-healing.

Virus & extracellular vessels or exosomes

Years ago, I was told that some scientists believe that viruses are actually fungal spores. It did not make sense that a nonliving entity was responsible for disease- there was something wrong with the foundational premise for disease because of only relaying part of the story. A virus is not a microbe for it is not alive until it is deposited into the living host and the word virus by association to disease is actually a very poor term. Extracellular vessels, EVs are important in cell-to-cell communication as well as pathogen-to-pathogen communication. EVs are small phospholipid membrane-enclosed entities that can carry microRNA (miRNA). A miRNA is a small single-stranded non-coding RNA molecule (containing about 22 nucleotides) that functions in RNA silencing and post-transcriptional regulation of gene expression. As scientists study deeper into this subject the line blurs between a virus and an EV and are now being exploited for vaccine technology. An example of fungal EVs contain RNA, proteins, melanin, lipid, and polysaccharides. EVs are fundamental to the complex cycle of life. EVs of bacteria can protect against disease supporting commensal growth or be pathogenic promoting inflammation in the host. EVs become indistinguishable from viruses the deeper we search. EVs associated with extracellular activity in the body could be broadly known as membrane vesicles, are found in great abundance in the water we drink and the air we breathe and of course the earth we take our food from. Microbes are affected by environmental factors through membrane vesicles. The microbes or cells are transformed accordingly. Viral payloads make life and its function possible and microbes make up the gut function without which we would not have immunity, get our nutrition or be able to function at all. Microbes morph themselves according to the environment in which they are found by EVs or membrane vesicles. This determines blood flow and quality and our self-healing.

There is vertical replication of the cells but also the horizontal influences by environmental factors and the outcome depends both on internal as well as external hygiene. This makes up the cycle of life allowing recycling and the regeneration of organic matter. 'Extracellular vessels important in cell-to-cell communication or EVs, depending on the proteins and genetic material incorporated in them, play a significant role in viral infection, both facilitating and suppressing it.'

'EVs can bind to the plasma membranes of other cells, enter them either through fusion or endocytosis, and trigger specific reactions from these recipient cells. Finally, EVs carry genetic material, and this genetic material can change functions of the recipient cell.' Extracellular vesicles and viruses: Are they close relatives? Esther Nolte-'t Hoen, Tom Cremer, Robert C. Gallo, and Leonid B. Margolis

If we were to let the body become filthy inside, the gene expression through EVs would mean lifethreatening parasites, bacteria and fungus would rapidly multiply and if present in a group could cause an epidemic that would cause death and plough us back into the ground thus recycling life and cleaning up the filth.

The body has several lines of defence against attack. When the last body defence has been broken in which the person is infected by disease this becomes part of the DNA thus a weak chain remains in the system rather than strengthening immunity. When the immune system is compromised the disease returns but has changed form and location, chickenpox presents as singles for example. Chickenpox is a very appropriate example as herpes infection (chicken pox) is possibly linked to COVID-19 vaccine, as risk increases among people with autoimmune inflammatory rheumatic diseases.

A background to mRNA medicines development

Discovered in 1961, mRNA has been studied and understood to be a template to build the body proteins. 'An mRNA is basically like a pre-form of a protein- its sequence codes. Nucleoside-modified messenger RNA a synthetic mRNA can cause a cell to make a protein, which in turn could directly treat a disease or could function as a vaccine. Having sequenced and patented Covid 19 in the USA, vaccines were developed for COVID-19. The vaccines developed by Pfizer and Moderna activate human proteins to take on "pathologic configurations."

One of the main problems in new range of drug development was overcoming the body's own defence system. "The mRNA molecule is vulnerable to destruction. So, in order to protect the fragile mRNA strands while they are being inserted into our DNA they are coated with PEGylated lipid nanoparticles. This coating hides the mRNA from our immune system which ordinarily would kill any foreign material injected into the body. PEGylated lipid nanoparticles have been used in several different drugs for years. Because of their effect on immune system balance, several studies have shown them to induce allergies and autoimmune diseases. Additionally, PEGylated lipid nanoparticles have been shown to trigger their own immune reactions, and to cause damage to the liver." Dr. Frank Shallenberger

The headline reads: 'Should the COVID-19 vaccine become mandatory for people who have no medical reason to refuse it? Should the government withhold welfare payments from those refusing to submit to the needle? Should employers be allowed to sack no-jab workers?'

Bill Gates is the name often associated with new vaccination technology. 'Pope Francis needs help in his mission to save the global economy from the rapidly accelerating triple threat of climate change, hunger and inequality.' And to add to this, the threat of Covid and so Gates has invested in vaccination to save millions of people in the world. (that's putting it simply without exploring other connections including his involvement with the Rockefeller foundation since 2010 and his close alliance with Dr. Fauci.) He may well be genuine but he does not belong to the children of light and sees the world in a totally different view. He sees new generation technology fixing the world with

genetically modified crops and genetically engineered medicines. Genetic engineering was something the antediluvians also experimented with. (This is not stating the mRNA vaccines changes your DNA but rather is part of the new, up and coming genetic engineering technology.) Many things start with good intentions that can easily follow down a bad path.

'Third shot may be needed to combat new coronavirus variants, Bill Gates says'. So where does it end? And what of the cocktail and how will that effect one's gut flora?

Could it be that there are many good meaning people looking at vaccination to save lives and coercion is believed to be beneficial? There is also a lot of media manipulation and herd mentality going on. Is this not a liberty of conscious issue? I think it is a God given issue for us to examine the underlying principles. 'We are not doing the will of God if we sit in quietude, doing nothing to preserve liberty of conscience.'

In 'project starfish' a genuine team of scientists were present at an experiment the pentagon was behind with only one scientist present who was really aware of the purpose of the experiment. Yet it was a crime against humanity.

The power of multinational drug companies is beyond that of many countries to have a say or state at what prices pharmaceutical goods will be sold to them. Now the monopoly is even greater and growing. God must soon take the reins in His own hands.

'A few men will combine to grasp all the means to be obtained in certain lines of business.'

It is very easy for drugs to keep spinning an income when they change form and location. (You see God gives us a little more insight than others.) It's a self-generating income- a licence to make money. It has been reported that 'The world has been taken over by ten corporations who control food, slaughterhouses, medicine and vaccines.' 'The global vaccines market size was USD 46.88 billion in 2019 and is projected to reach USD 104.87 billion by 2027, exhibiting a CAGR of 10.7% during the forecast period.' This is part of a new era in drug development that is being integrated in with biometrics as part of the 4th industrial revolution. This is the cusp of a new era of medicine of which Covid vaccines is just the tip. This will be applied to multiple diseases such as cancer and diabetes and so on, relying more and more on artificial **intelligence** (AI). World domination is possible like never before because of the coming AI revolution. The book, 'Keys of this Blood' said it would be the biggest change in a thousand years. Christiana Figueres of the UN in 2015, said it will be the biggest change since the industrial revolution. So, when is it coming? Can we really not see it? So, was Covid an interruption of that plan or an implementation of the plan for inclusive capitalism? It would appear from the news reports coming in from many directions that a '1000 masked batteries' are being prepared for God's people right now!

'Drugmakers are already discussing whether they should make a new, tuned vaccines that better protect against new variants, much like they do every year with flu shots.'

On top of this we have the conspiracies arising from past research articles on gain- of- function technology which makes a virus more virulent and Newsweek reporting 7.4 million that was given to the Wuhan lab from the US over 6 years and Fauci's involvement. (It would be interesting if this was tried in a law court for criminal investigation) Bioweapons were always ready to be developed from multiple labs around the world. A little-known company moderna grew from a \$56 million grant from the US defense department DARPA (The Defense Advanced Research Projects Agency - associated with the CIA), in 2014 to the place of vaccine development seen today. Could it be that the 4th industrial revolution with genetic engineering using mRNA that came from DARPA is God's saving hand? Or is it to counteract God's work? The internet which gives us all this information, from which Gates profited also came from DARPA. I believe at every step of the way Lucifer through his agents, will counterfeit the 3 angels' messages of which our health message is an important part.

The development of next-generation medicines is an interesting one and an integral part of the 4th industrial revolution taking shape now, associated with artificial intelligence. Without DARPA we would not be where we are today. mRNA drug development was considered too risky a venture for private business at the inception. DARPA is the cutting edge of weaponry, cyborgs, artificial intelligence, etc, and DNA technology. DARPA played an important role in helping Moderna establish its mRNA platform, awarding the biotech a contract and funding up to \$56 million. Bill Gates and Dr. Fauci are the names often associated with this development however Silicon Valley big tech would be welcomed aboard later for-profit and private funding but it was a development of the US defense initiative.

The concept of world vaccination maybe a frightening concept. 'Just like a flu shot': People may need to take Covid-19 vaccine annually 'for the next several years', says Johnson & Johnson CEO 10 Feb, 2021.

Something to consider is this quote: "One individual may be killed by a virus while another may have no ill effects from the same virus. By placing the identical receptor, the spike protein, on cells of everyone in a population, the genetic diversity for at least one potential receptor disappears. Everyone in the population now becomes potentially susceptible to binding with the same infectious agent." COVID-19 RNA Based Vaccines and the Risk of Prion Disease J. Bart Classen, MD

When a person gets a vaccination, we are not expecting them to have immediate adverse effects. However, when this occurs particularly with news items relating to Pfizer it is stated these people would have died anyway because of comorbidities but that's the very reason for the vaccinations!! That's how the whole thing started. 'We needed to protect the vulnerable.'

When we consider chicken pox, we see an example of how disease works. Sooner or later shingles can appear or having had the vaccination for singles it appears anyway. When you understand physiology in its truest sense, your drug bills will be very much smaller, and finally you will cease to deal out drugs at all. The physician who depends upon drug medication in his practice shows that he does not understand the delicate machinery of the human organism. He is introducing into the system a seed crop that will never lose its destroying properties throughout the lifetime. I tell you this because I dare not withhold it. Christ paid too much for man's redemption to have his body so ruthlessly treated as it has been by drug medication. {MM 229.2}

There are principals so simple and basic that are contained in inspiration that they are not considered and not used; for which the world is dying.

We in our up- to -date thinking equate the words of Ellen White concerning drugs as belonging to her time and we do this with theology and prophecy as well. When we consider quarantine in Leviticus it was not to shut down the whole country. The countries of course are being run bankrupt. Covid has a multipurpose effect that nothing else like it could, to bring in the 'new normal.'

Is vaccination a clean means of healing? Well in the traditional vaccine there is mercury, aluminium, fish oil, beef serum, pig serum, gelatine and formaldehyde causing cancer. This is not stated in the ingredients however. Using disease to fight disease leaves the system with underlying disease or seed, and when the immune system is compromised it manifests itself. Now the mRNA vaccines are different to that which we just stated.

"No vaccine has ever worked." Dr Shiv Chopra, PhD Microbiologist, vaccine expert.

The new vaccines have had caused blood clots leading to death in some, associated with the new vaccines but despite the ongoing reports of death, there is continued denial. Long term effects of this new technology are still unknown.

'The regulator launched its review into the jab after 13 states across Europe suspended use of the vaccine over fears of a link to blood clots.'

The review specifically investigated seven cases of blood clots in multiple blood vessels right throughout the body (DIC) and 18 cases of cerebral venous sinus thrombosis (CVST), nine of which resulted in death. Dr Shelley Deeks (Canada), vice-chair of the National Advisory Committee on Immunisation said the updated recommendations came amid new data from Europe that suggested the risk of blood clots was potentially as high as one in 100,000, much higher than the one in 1 million risk believed before. https://www.theguardian.com/world/2021/mar/30/canada-suspends-use-of-astrazeneca-covid-vaccine-for-those-under-55. Yet the chief Australian health adviser Professor Paul Kelly stated the benefits outweighed the risks despite what is considered acceptable levels of risk and that's in the face of Australia's low number of covid 19 cases.

The coronavirus pandemic can only be considered beaten once everyone in the world has been immunized against Covid-19, Germany's Chancellor Angela Merkel said, after she'd met with the G7 leaders at a virtual summit on Friday.

The vaccines are acknowledged to "may not protect everyone...The duration of (alleged) protection against COVID-19 is currently unknown."

"The World Health Organization (WHO) warned there is no guarantee that COVID-19 vaccines will prevent people from being infected with the SARS-CoV-2 virus and transmitting it to other people.

- Vaccinated persons still need to mask and social distance because they could be able to spread the new coronavirus to others without knowing it, according to WHO and U.S. health officials.
- As with measles and polio, there is no guarantee of eliminating the SARS-CoV-2 virus through mass vaccination programs.
- There is a possibility the U.S. government will introduce "COVID-19 vaccine passports" and that some local governments and businesses will make COVID-19 vaccines mandatory, including in schools.
- Technology companies have been working on creating a digital certificate, which contains
 personal medical information giving evidence that an individual has been vaccinated and
 which can be used as a screening tool by employers and businesses."

The argument for the aged & venerable

The argument goes from the onset of covid 19, that we need to do the social distancing and lockdowns for the venerable. But this was not just isolated to those with impaired immune systems and chronic diseases, this was for everyone. Then we heard you need to get vaccinated for the people you love and by not doing so you were being irresponsible.

The reality is that those that do not follow hygiene health laws are irresponsible to themselves and others but that is their choice just like choosing to smoke cigarettes. The focus of government health agencies was on environmental hygiene however this did not include getting out in the fresh air or

making sure there were free flowing air systems in nursing homes and hospitals. The reality is that these facilities because of the enclosures put visitors, staff and the venerable at risk.

Many are totally ignorant of health principals and that is because of the money made in the medical industry by big pharma and poor education, at school and tertiary levels. A vegan eating 2 quality meals a day, with plenty of outdoor activity and exercise, fresh air, water, good rest patterns and no drug or substance abuse is headed toward making a hydrated nutrient rich, clean internal environment that promotes good microbial gut flora.

We heard after a short time that some people with comorbidities, that is the vulnerable, were dying from complications after vaccination. So, through the media, politicians, and medical elite the whole phycology of the argument was reversed. The venerable are at risk of covid and need to be careful and with the vaccination the venerable are placed at further risk. Further risk does not necessarily mean sudden death within weeks of vaccination or side effects but for many there were these immediate consequences, from high fever, to being temporarily paralysed, to stopping the mistral cycle, to clots on the brain, which was for the most part remain unpublished. There will be side effects that will not be realised for years to come that remain dormant until the immune system is compromised further, allowing a worse disease to manifest itself. Hospitalized or fatal COVID-19 vaccine breakthrough cases reported to CDC as of August 2, 2021

As of August 2, 2021, more than 164 million people in the United States had been fully vaccinated against COVID-19.

During the same time, CDC received reports from 49 U.S. states and territories of 7,525 patients with COVID-19 vaccine breakthrough infection who were hospitalized or died.

"These are people who died from COVID, from complications of COVID, despite being vaccinated because the vaccine is not 100% [effective] and people with weakened immune systems, people who are a little bit older, and some people for reasons we don't really understand, might not mount a full immune response to the vaccine," Dr. Joseph

Kanter, Louisiana state health officer and medical director. This was stated after 27 people between the ages of 28 and 93 died with COVID more than two weeks after being fully vaccinated.

'Pfizer has a long track record of fines and Moderna has never produced a successful vaccine but you will still be rolling up your sleeves for their respective vaccine!'

Richard Horton, editor of the Lancet, opined: "Even scientific journals, supposedly the neutral arbiters of quality by virtue of their much-vaunted process of critical peer review, are owned by publishers and scientific societies that derive and demand huge earnings from advertising by drug companies and from the sale of commercially valuable content." Additionally, Horton believes medical "journals have devolved into information-laundering operations for the pharmaceutical industry." Richard Smith, a former editor and chief executive of the British Medical Journal for 13 years, published an article entitled: "Medical Journals Are an Extension of the Marketing Arm of Pharmaceutical Companies." In it, he shows the multifaceted approach drug companies use to manipulate data and gain influence over physicians and peer review publications. In another article, he reveals the peer review process to be "slow, expensive, ineffective, something of a lottery, prone to bias and abuse, and hopeless at spotting errors and fraud." According to Smith, even though peer

review is considered a "sacred process," studies reveal its assumed benefits are difficult to establish. An article written by Vedula et al., observed a systematic effort by Pfizer, a drug company, to distort scientific findings and deliver misinformation to healthcare providers about their drugs. For these activities, Pfizer was fined \$2.3 billion in 2009. Part of the reason for the large fine is due to Pfizer engaging in bribery with medical officials. It would be nice if Pfizer was a lone actor or "bad apple," but the evidence and legal penalties reveal otherwise. David Klemperer, a professor



of sociology at the University of Regensburg, examined the corrupting influence of the drug industry on the peer review process and wrote: "There is no secret to how the desired results are fabricated. It is possible to give a study a spin into the desired direction at any stage of the research process. The results will differ according to what the research question is, which of the possible end points are included, which patients are included or excluded, what is being compared, and which study period is selected. In the evaluation, it is common practice to change primary and secondary endpoints without disclosure. Suppressing results that might constitute an obstacle to marketing a substance, as well as the re-interpretation of negative and unclear results as positive results, are further methods of manipulation. Pharmaceutical companies often leave both doctors and patients in the dark about the real effects of their products. The knowledge base on which we as doctors


FDA Safety Surveillance of COVID-19 Vaccines: DRAFT Working list of possible adverse event outcomes

The CDC and FDA had a good idea of what was to eventuate from the vaccinations as listed in October 2020 by these organisations before the release of the vaccines. This should be no surprise but underlines the true nature of drug therapies. The concern is when as is occurring now there are more deaths from vaccines as reported by government agencies than deaths from covid.

Pfizer and Moderna use Polyethylene glycol 2000 to punch holes in the Brian Barrier and deliver chemical inside the shots to brain material with the potential to cause nerve damage. Johnson and Johnson has Polysorbate 80 which delivers a transgene, a double stranded DNA. These deliver genetically modified material to the brain to get your body to produce spike proteins. mRNA makes its way into your DNA and makes the DNA spike proteins on the cell's exterior, to make your own cells look like the coronavirus. Your body produces antibodies to attack your cells. Approx. 50 billion spike proteins are produced. The spike protein is what gives the coronavirus family of viruses their name. The spikes jut out from the surface of the spherical virus, giving it a crown-like halo, hence "corona".

Covid 19 is a vascular disease

The paper, published on April 30, 2021, in *Circulation Research*, also shows conclusively that COVID-19 is a vascular disease, demonstrating exactly how the SARS-CoV-2 virus damages and attacks the vascular system on a cellular level.



"The findings help explain COVID-19's wide variety of seemingly unconnected complications, and could open the door for new research into more effective therapies. A lot of people think of it as a respiratory disease, but it's really a vascular disease," says Assistant Research Professor Uri Manor, who is co-senior author of the study. "That could explain why some people have strokes, and why some people have issues in other parts of the body. The commonality between them is that they all have vascular underpinnings. Salk researchers collaborated with scientists at the University of California San Diego on the paper, including co-first author Jiao Zhang and co-senior author John Shyy, among others. While the findings themselves aren't entirely a surprise, the paper provides clear confirmation and a detailed explanation of the mechanism through which the protein damages vascular cells for the first time. There's been a growing consensus that SARS-CoV-2 affects the vascular system, but exactly how it did so was not understood. Similarly, scientists studying other coronaviruses have long suspected that the spike protein contributed to damaging vascular endothelial cells, but this is the first time the process has been documented. In the new study, the researchers created a "pseudovirus" that was surrounded by SARS-CoV-2 classic crown of spike proteins, but did not contain any actual virus. Exposure to this pseudovirus resulted in damage to the lungs and arteries of an animal model—proving that the spike protein alone was enough to cause disease. Tissue samples showed inflammation in endothelial cells lining the pulmonary artery walls. The team then replicated this process in the lab, exposing healthy endothelial cells (which line arteries) to the spike protein. They showed that the spike protein damaged the cells by binding ACE2. This binding disrupted ACE2's molecular signaling to mitochondria (organelles that generate energy for cells), causing the mitochondria to become damaged and fragmented. Previous studies have shown a similar effect when cells were exposed to the SARS-CoV-2 virus, but this is the first study to show that the damage occurs when cells are exposed to the spike protein on its own. "If you remove the replicating capabilities of the virus, it still has a major damaging effect on the vascular cells, simply by virtue of its ability to bind to this ACE2 receptor, the S protein receptor, now famous thanks to COVID," Manor explains. "Further studies with mutant spike proteins will also provide new insight towards the infectivity and severity of mutant SARS CoV-2 viruses. "The researchers next hope to take a closer look at the mechanism by which the disrupted ACE2 protein damages mitochondria and causes them to change shape.

Other authors on the study are Yuyang Lei and Zu-Yi Yuan of Jiaotong University in Xi'an, China; Cara R. Schiavon, Leonardo Andrade, and Gerald S. Shadel of Salk; Ming He, Hui Shen, Yichi Zhang, Yoshitake Cho, Mark Hepokoski, Jason X.-J. Yuan, Atul Malhotra, Jin Zhang of the University of California San Diego; Lili Chen, Qian Yin, Ting Lei, Hongliang Wang and Shengpeng Wang of Xi'an Jiatong University Health Science Center in Xi'an, China. The research was supported by the National Institutes of Health, the National Natural Science Foundation of China, the Shaanxi Natural Science Fund, the National Key Research and Development Program, the First Affiliated Hospital of Xi'an Jiaotong University; and Xi'an Jiaotong University. The European database of suspected drug reaction reports is <u>EudraVigilance</u>, which also tracks reports of injuries and deaths following the experimental COVID-19 "vaccines."

The EudraVigilance database reports that through June 19, 2021 there are **15,472 deaths and 1,509,266 injuries** ..

From the total of injuries recorded, half of them (753,657) are **serious** injuries.

"Seriousness provides information on the suspected undesirable effect; it can be classified as 'serious' if it corresponds to a medical occurrence that results in death, is life-threatening, requires inpatient hospitalisation, results in another medically important condition, or prolongation of existing hospitalisation, results in persistent or significant disability or incapacity, or is a congenital anomaly/birth defect."



Centers for Disease Control and Prevention announced Thursday that it will convene an "emergency meeting" of its advisers on June 18th to discuss rare but higher-than-expected reports of heart inflammation following doses of the mRNA-based Pfizer and Moderna COVID-19 vaccines.

The new details about myocarditis and pericarditis emerged first in presentations to a panel of independent advisers for the Food and Drug Administration, who are meeting Thursday to discuss how the regulator should approach emergency use authorization for using COVID-19 vaccines in younger children.

As CBS reports, the CDC previously disclosed that reports of heart inflammation were detected mostly in younger men and teenage boys following their second dose, and that there was a "higher number of observed than expected" cases in 16- to 24-year-olds. Last month, the CDC urged providers to "ask about prior COVID-19 vaccination" in patients with symptoms of heart inflammation.

A case report examining myocarditis in seven adolescents following vaccination with Pfizer's jab, published in Pediatrics, the journal of the American Academy of Pediatrics, this month, said all seven developed the inflammation within 4 days of receiving the second dose, did not have evidence of COVID-19 infection, and did not meet the criteria for MIS-C, a rare disease.

The seven males, between the ages of 14 and 19, all required hospital care but each was eventually discharged.

Authors, who did not respond to requests for comment, said no link has been established between the vaccines and myocarditis and that the benefits of the vaccines outweigh the risks. But they also urged healthcare workers "to consider myocarditis in the evaluation of adolescents and young adults who develop chest pain after COVID-19 vaccination."

A commentary on the study published in the same journal, said "there are some concerns regarding this case series that might suggest a causal relationship and therefore warrant further analysis through established surveillance systems."

"First, the consistent timing of symptoms in these seven cases after the second vaccination suggests a uniform biological process. Second, the similarities in clinical findings and laboratory characteristics in this series suggest a common etiology. Finally, these cases occurred in the context of a dearth of circulation of common respiratory viruses known to be associated with myocarditis, and thorough diagnostic evaluations did not identify infectious etiologies," they added.



"Just as antibiotics breed resistance in bacteria, vaccines can incite changes that enable diseases to escape their control. Researchers are working to head off the evolution of new threats.

In a 2014 paper published in *Emerging Infectious Diseases*, researchers in Australia, led by the medical microbiologist Ruiting Lan at the University of New South Wales, collected and sequenced *B. pertussis* samples from 320 patients between 2008 and 2012. The percentage of bacteria that did not express pertactin, a protein targeted by the acellular vaccine, leapt from 5 percent in 2008 to 78 percent in 2012, which suggests that selection pressure from the vaccine was enabling pertactin-free strains to become more common. In the U.S., nearly all circulating viruses lack pertactin, according to a 2017 CDC paper. "I



think pretty much everyone agrees pertussis strain variation is shaped by vaccination," Lan said.

Hepatitis B, a virus that causes liver damage, tells a similar story. The current vaccine, which principally targets a portion of the virus known as the hepatitis B surface antigen, was introduced in the U.S. in 1989. A year later, in a paper published in the *Lancet*, researchers described odd results from a vaccine trial in Italy. They had detected circulating hepatitis B viruses in 44 vaccinated subjects, but in some of them, the virus was missing part of that targeted antigen. Then, in a series of studies conducted in Taiwan, researchers sequenced the viruses that infected children who had tested positive for hepatitis B. They reported that the prevalence of these viral "escape mutants," as they called them, that lacked the surface antigen had increased from 7.8 percent in 1984 to 23.1 percent in 1999." Summary

Despite over 140 million SARS-CoV-2 infections worldwide since the beginning of the pandemic, relatively few confirmed cases of SARS-CoV-2 reinfection have been reported. While immunity from SARS-CoV-2 infection is probable, at least in the short term, few studies have quantified the reinfection risk. To our knowledge, this is the first systematic review to synthesise the evidence on the risk of SARS-CoV-2 reinfection over time. A standardised protocol was employed, based on Cochrane methodology. Electronic databases and preprint servers were searched from 1 January 2020 to 19 February 2021, Eleven large cohort studies were identified that estimated the risk of SARS-CoV-2 reinfection over time, including three that enrolled healthcare workers and two that enrolled residents and staff of elderly care homes. Across studies, the total number of PCR-positive or antibody-positive participants at baseline was 615,777, and the maximum duration of follow-up was more than 10 months in three studies. Reinfection was an uncommon event (absolute rate 0%-1.1%), with no study reporting an increase in the risk of reinfection over time. Only one study estimated the population-level risk of reinfection based on whole genome sequencing in a subset of patients; the estimated risk was low (0.1% [95% CI: 0.08-0.11%]) with no evidence of waning immunity for up to 7 months following primary infection. These data suggest that naturally acquired SARS-CoV-2 immunity does not wane for at least 10 months post-infection. However, the applicability of these studies to new variants or to vaccine-induced immunity remains uncertain

"Despite the high number of infections evidence shows that there is virtually no reinfection because of natural immunity.

Eleven large cohort studies were identified that estimated the risk of SARS-CoV-2 reinfection over time, including three that enrolled healthcare workers and two that

enrolled elderly care home residents. All studies reported low relative SARS-CoV-2 reinfection rates in individuals with prior evidence of infection, compared with those O MURCHU ET AL. - 9 of 11 without, for up to 10 months. The relative risk of reinfection was low across studies, although there was some inconsistent evidence of a higher risk in older populations compared with younger populations. A limitation of this review was the uncertainty regarding the applicability of data to new variants of concern and to vaccinated populations." Quantifying the risk of SARS-CoV-2 reinfection over time.

Despite this evidence of natural immunity being as effective, if not superior to the vaccine, the push is to vaccinate those who already have natural immunity citing the risk of the covid variant which is known to be highly infectious but less deadly. Detection of Glyphosate Residues in Animals and Humans

In the present study glyphosate residues were tested in urine and different organs of dairy cows as well as in urine of hares, rabbits and humans using ELISA and Gas Chromatography-Mass Spectroscopy (GC-MS). The correlation coefficients between ELISA and GC-MS were 0.96, 0.87, 0.97and 0.96 for cattle, human, and rabbit urine and organs, respectively. The recovery rate of glyphosate in spiked meat using ELISA was 91%. Glyphosate excretion in German dairy cows was significantly lower than Danish cows. Cows kept in genetically modified free area had significantly lower glyphosate concentrations in urine than conventional husbandry cows. Also glyphosate was detected in different organs of slaughtered cows as intestine, liver, muscles, spleen and kidney. Fattening rabbits showed significantly higher glyphosate residues in urine than hares. Moreover, glyphosate was significantly higher in urine of humans with conventional feeding. Furthermore, chronically ill humans showed significantly higher glyphosate residues in urine than healthy population. The presence of glyphosate residues in both humans and animals could haul the entire population towards numerous health hazards, studying the impact of glyphosate residues on health is warranted and the global regulations for the use of glyphosate may have to be re-evaluated.
