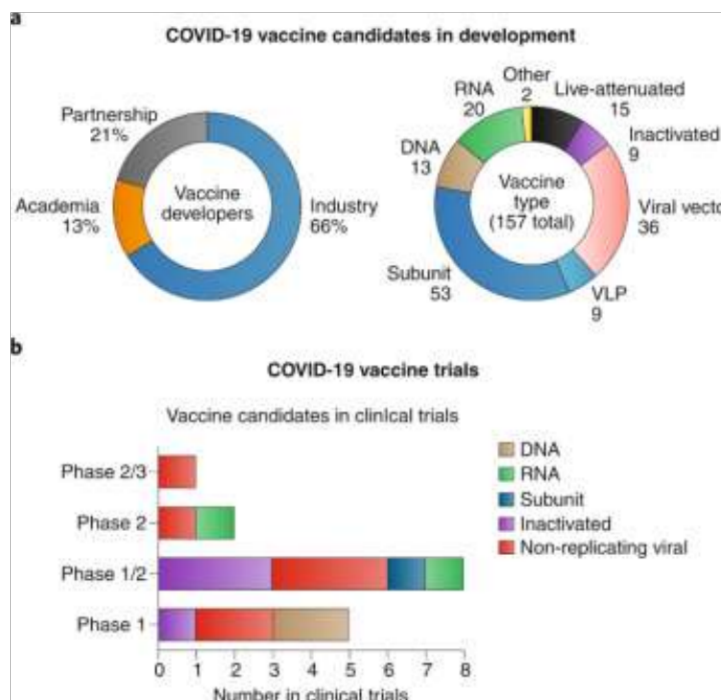

Assessment of the virome of 8,240 healthy adults found the presence of the HIV virus, the hepatitis B virus, the hepatitis C virus, and the influenza virus in many individuals.

- Are the covid mRNA vaccine as other vaccines? This class of vaccine viral vector and mRNA Vaccine has been developed over 15 years for SARS-1. With this in mind it is clear that this is not a new development and the side effects had already been studied during development. AstraZeneca uses a benign virus, viral vector or carrier (which has been deactivated) to instruct the cell to make the spike protein. 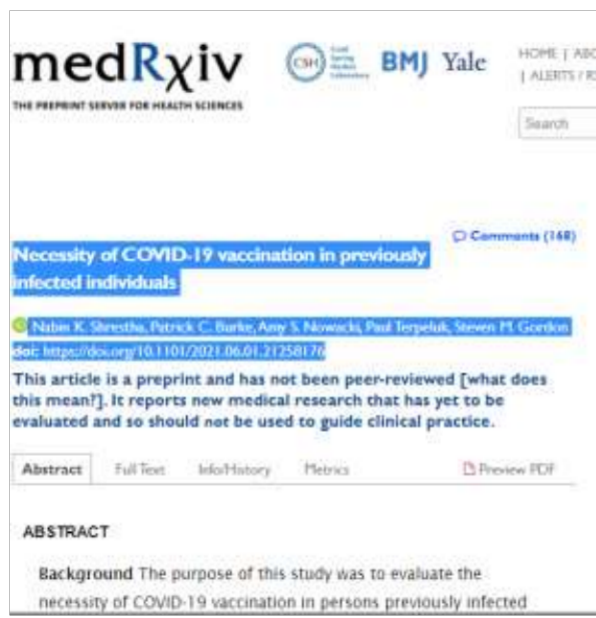

It means that the memory response of the vaccination is highly inferior to the body's natural immune response and memory.

Is natural immune response pathogen dependant? No, it is healthy microbiome dependant and that depends on a mineral rich hygienic internal environment.

Immune response memory and defence depend on nutrients and that is delivered through internal hygiene. The immune response is nutrient dependent which is vital for immune response memory. Lymphocytes are transformed into T and B blast cells only when there is sufficient nutrient levels such as vitamin C. T and B blast cells are precursors of the effector cell in both mediated and humoral immunity.

The Australian Medical Association (AMA) has adopted the World Medical Association's declaration of Geneva, which states: " I will not use my medical knowledge to violate human rights and civil liberties, even under threat." However, earlier this year, The Medical Board of Australia and the Australian Health Practitioner Regulatory Agency (AHPRA) issued a joint directive warning members they risk disciplinary action for providing 'false or deceptive' advice or information that could undermine the national vaccination program.

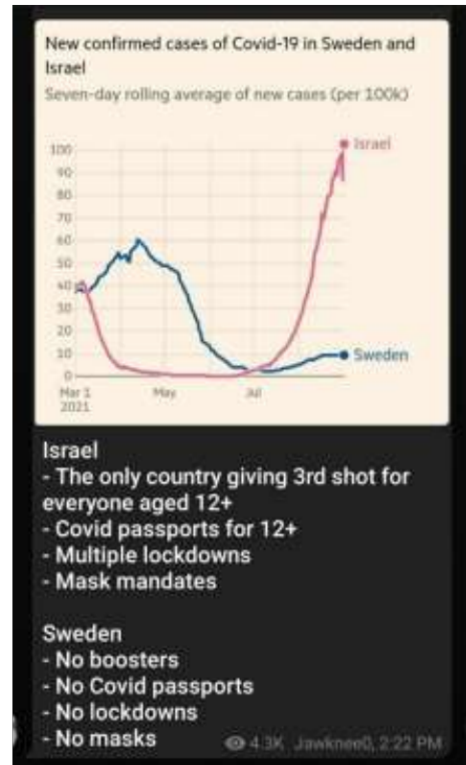
Ultra-Vaxxed Israel’s Crisis Is a Dire Warning to America

More than 350 people have died of the disease in the first three weeks of August. In a Sunday press conference, the directors of seven public hospitals announced that they could no longer admit any coronavirus patients.

With 670 COVID-19 patients requiring critical care, their wards are overflowing and staff are at breaking point. “I don’t want to frighten you,” coronavirus czar Dr. Salman Zarka told the Israeli parliament this week. “But this is the data. Unfortunately, the numbers don’t lie.”..... **But in early July, with citizens over the age of 60 almost completely vaccinated, Israeli scientists began observing a worrisome rise in infections—if not in severe illness and death—among the double-vaccinated. Fully vaccinated people with weakened immune systems appeared particularly vulnerable to the aggressive Delta variant.”** So, the answer to this—another vaccine right! 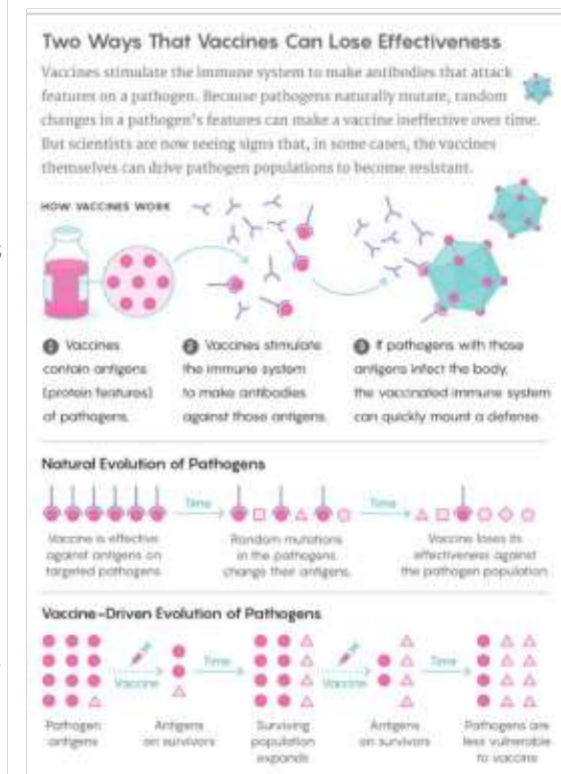
Vaccines drive the mutation of the pathogen.

In a [2014 paper](#) published in *Emerging Infectious Diseases*, researchers in Australia, led by the medical microbiologist [Ruiting Lan](#) at the University of New South Wales, collected and sequenced *B. pertussis* samples from 320 patients between 2008 and 2012. The percentage of bacteria that did not express pertactin, a protein targeted by the acellular vaccine, leapt from 5 percent in 2008 to 78 percent in 2012, which suggests that selection pressure from the vaccine was enabling pertactin-free strains to become more common. In the U.S., nearly all circulating viruses lack pertactin, according to a [2017 CDC paper](#).

"I think pretty much everyone agrees pertussis strain variation is shaped by vaccination"

Lan said.

Hepatitis B, a virus that causes liver damage, tells a similar story. The current vaccine, which principally targets a portion of the virus known as the hepatitis B surface antigen, was introduced in the U.S. in 1989. A year later, in a paper published in the Lancet, researchers described odd results from a vaccine trial in Italy. They had detected circulating hepatitis B viruses in 44 vaccinated subjects, but in some of them, the virus was missing part of that targeted antigen. Then, in a [series of studies conducted in Taiwan](#), researchers sequenced the viruses that infected children who had tested positive for hepatitis B. They reported that the prevalence of these viral "escape mutants," as they called them, that lacked the surface antigen had increased from 7.8 percent in 1984 to 23.1 percent in 1999."

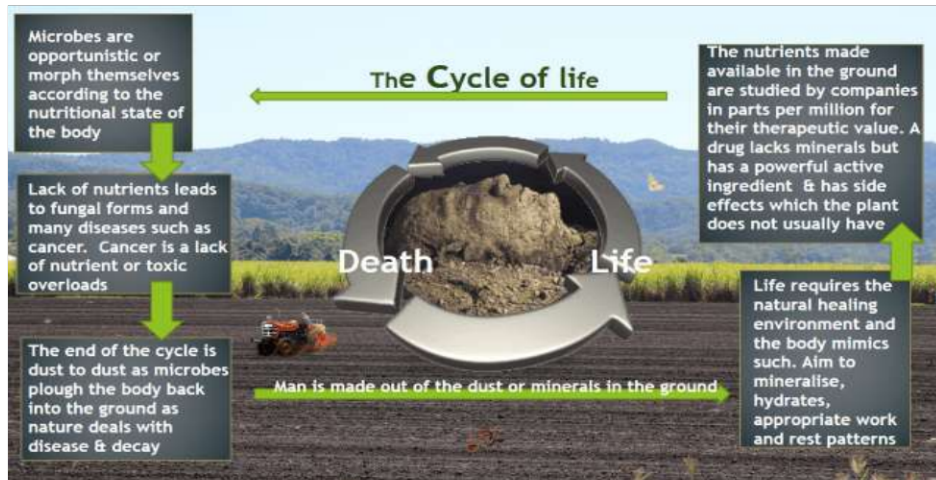
staphylococcus aureus, or "golden staph" infections, on two-thirds of hospital patients, where conventional antibiotics were ineffective." 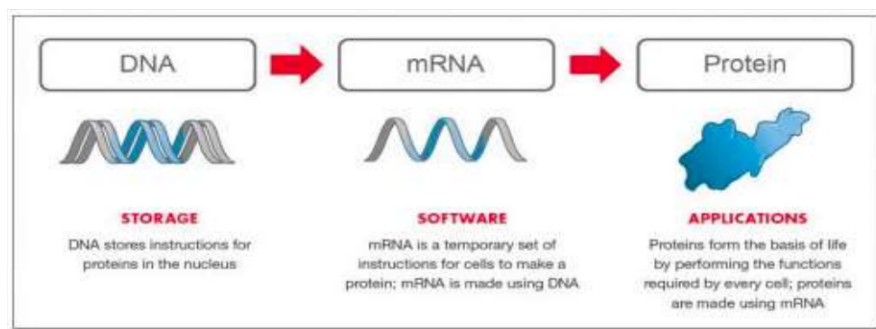

Papal vaccine campaigns offered punishments, rewards 200 years ago

VATICAN CITY — When popes were king, they ordered all their subjects in the Papal States to be vaccinated, using punishments and rewards to convince the hesitant and making sure the poor and the prisoners were inoculated as well.

Vatican News recounted how, as a smallpox epidemic swept central Italy at the end of the 1700s and beginning of the 1800s, Pope Pius VII threw the full weight of his temporal power behind a vaccination campaign.

The text of a law promulgated June 20, 1822, by Pope Pius' secretary of state, Cardinal Ercole Consalvi, described the new smallpox vaccine as a gift "put in place by divine providence" as a sign of God's "paternal love to save his children."

But the text noted that not everyone saw the vaccine as a gift, and it denounced appearances that "a deep-rooted prejudice was stronger in some parents than the love of their offspring."

"The legislation specified that to obtain subsidies, benefits or premiums, it was necessary to provide the 'certificate showing that the applicant, being the father of a family, has had the vaccination,'" said the Vatican News report May 7.

Refusing the vaccine was defined as "reprehensible conduct" punishable by a loss of benefits.

The pope set up committees to oversee the vaccination campaign and tied the licensing of physicians to their willingness to vaccinate patients, the report said.

But two years later, Pope Leo XII, who succeeded Pope Pius in 1823, removed the vaccination obligation.

And his efforts drew the praise of one of Rome's most famous poets, Giuseppe Gioachino Belli, who wrote a sonnet extolling the virtues of the new pope who "liberated" his people from an invention of "the Freemasons" and restored the possibility that God alone would decide when it was time for someone to die.

Pope Gregory XVI, elected in 1831, restarted the vaccination campaign and extended it to all prisoners as well. Pope Pius IX, the last of the popes with temporal power, continued the campaign and designated a financial reward of "two paoli" — 20 cents of a scudo — for those who returned eight days after being vaccinated to have its efficacy checked, the Vatican News report said.

The Jesuits used the inquisition to exterminate those that kept God's law, the very foundation for health, salvation and happiness.

If the suspected heretic refuse to confess her error and sufficient eyewitness testimony against her, she would be relaxed to the secular arm, a phrase
